Sir,

I am directed to convey the approval of the President for the financial support from the Department of Biotechnology, Ministry of Science & Technology at a total cost of Rs. 63.77 Lakhs (RUPEES SIXTY THREE LAKH AND SEVENTY SEVEN THOUSAND ONLY) including salaries of staff as detailed in Annexure-I for a period of 3.00 years (from the date of receipt of grant by host/grantee institution/organisation), to Dr. O. Sadiqi, Tata Institute of Fundamental Research, Homi Bhabha Road, Bombay for the above mentioned project. The details of the budget breakup is given in Annexure-1.

2. The DEI agrees to defray the expenditure incurred towards salaries for the staff positions as indicated in the Annexure-1 and deployed by the host institution for the implementation of the Project. It is the responsibility of the host institution to follow their own prescribed procedure for creation of posts as well as filling up of those positions.

3. The objectives of the project are:

- Genetic and molecular analysis of the receptor system on the antenna and proboscis of the fly
- Transmission of the ensuing signals to the antennal lobes and the sub-oesophageal ganglion identification of the molecular components of the olfactory and gustatory transduction.

- Clone Drosophila homologs of vertebrate olfactory signal transduction components like G-protein and G-protein-coupled receptors. -- Screening of antennal cDNA library with vertebrate cDNA probes at low stringency.
- Screening the mRNA from Drosophila antenna and proboscis

4. I am also directed to convey the Sanction of the President to the payment of Rs.33.00000 Lakhs ( RUPEES THIRTY THREE LAKH ONLY ) as first year release/instalment for the financial year 1994-95. The details are given below (For detailed heads of Accounts please see Annexure-I ) :-
